Councillor R. Hughes informed that three dog litter bins had been sited, one in Pontblyddyn, one on County Road, and one at the junction of the lane to Leeswood Green Farm, two additional dog litter bins are to be sited.

Councillor K. McCallum informed that commemorative five pound crowns, had been handed out at Mold R.C. Infants School, and that the pupils were very pleased to have received them.

POLICE LIAISON:

Councillor R. Hughes informed that Andrea Ellis, had now moved as the P.C.S.O. to Hope and Caergwrle, her replacement is Lisa Hughes.

The Clerk informed that he had informed the new C.B.M., P.C. Gary Aldous, of the revised date of the meeting.

Councillor C.E. Jones expressed his concern at the way the village is going, he referred to the presence of drugs, and an incident which he had witnessed.

He also mentioned a premises which is regularly visited by suspicious persons.

Councillor R. Hughes informed that the police are watching three properties in the village.

The Vice Chairman, Councillor K. McCallum informed that approximately three weeks ago he had been speaking with Andrea Ellis, who informed that the police will not attend future meetings unless there is a written request.

Councillor Mrs. J. Atkinson expressed that she was disappointed that the police were not present at the meeting, as she and Councillor Mrs. C. Bie had a list of complaints, including items stolen from properties and from garages, and that the residents in Pontblyddyn do not feel safe.

The Chairman, Councillor Miss. M. Reynolds, referred that she had spoken to people in Leeswood, and that they are becoming unnerved.

Councillor T. Hughes suggested that the police should most certainly be invited to a Special Meeting and in addition to the new Support Officer there should be a higher ranking officer.

Councillor C. Jones referred to double parking in Bryn Clyd.

RESOLVED:

That the Community Beat Manager, P.C. Gary Aldous be invited to a Special Meeting of the Community Council to be convened for Tuesday the 2nd October, 2012.

88.

ACQUISITION OF LAND – CEMETERY REQUIREMENTS:

The Clerk reported that himself along with the Chairman, Councillor Miss. M. Reynolds, Councillor R. Hughes, the Chairman of the Sub Committee, and Councillor Carlton Jones had met with Mr. Graham Halstead, owner of the parcel of land adjacent to the English Methodist Chapel.

Mr. Halstead's offer of land was linked to a condition that he would be successful in gaining planning consent for a housing development.

The Chairman, Councillor Miss. M. Reynolds, substantiated this by describing it as a substantial housing development.

Councillor R. Hughes explained that Mr. Halstead wanted permission to build 36 properties, at present moment he had outline consent for 3, but if he built the 3, then the area of land to the rear would become land locked.

Councillor C. Jones informed that Mr. Halstead had written to the church, requesting access through the church's land onto the ground, and that the Reverend Trefor Pratt was considering the matter.

Councillor Mrs. J. Atkinson posed the question could we purchase land above the existing cemetery, Councillor R. Hughes referred to what would be the exorbitant cost of draining the area, initially an amount of £20,000 was spent on draining the existing area.

The Clerk explained that he had not been able to make contact with the occupant of the new house close to the cemetery.

Councillor R. Hughes doubted whether permission for access onto this area of land could be gained, as a result of the existence of the acute bend.

The possibility of approaching Mr. George Owen was again broached, the point was made that the Community Council cannot be held ransom, taking into account the exorbitant amount of money that is being asked by Mr. Owen.

RESOLVED:

That the foregoing dialogue be recorded and that the Clerk attempts to make contact with the household referred to above.

FIELDS IN TRUST – QUEEN ELIZABETH II FIELD CHALLENGE:

Correspondence received from the Director of Life Long Learning informed that the County Council has approved 17 nominated recreation grounds to be submitted to Fields in Trust for inclusion in the scheme. The fact that Fields in Trust has subsequently confirmed that the sites meets its criteria represents a fantastic achievement for the County.

The County Council is in the process of completing the documentation for the legal dedication of land, and upon completion the authority will be arranging an event to celebrate the achievement.

Members were aware that the Phoenix Park play area is included as one of the recreation grounds.

Councillor R. Hughes reminded members that as a result of this the Phoenix Park play area will always be a recreation area.

RESOLVED:

ANNUAL RETURN TO 31ST MARCH 2012:

Members had been previously circulated with a copy of the External Auditors report, which informed that it is the Auditor's intention to issue an unqualified Audit Certificate and to report there are no matters which he considers needs to be drawn to the attention of the Council.

CASTLE CEMENT LIAISON COMMITTEE:

With regard to the contents of the smaller particles in the atmosphere there was no current technology to identify what they contained.

Councillor Caruana informed that the smaller the particles are the easier they can penetrate the lungs, he assured members that he would be continuing to push for the necessary expertise to identify what the particles contained.

Councillor R. Hughes informed that County Road was now on the list for tarmacing along with improvements to Britannia Road.

A traffic census was to be carried out on Dingle Road, and that the residents would also be consulted with.

LITTER PICKING:

Councillor C.E. Jones referred that on a Wednesday the village is litter picked by operatives of the Flintshire County Council, and on a Thursday Mr. Richards carries out a litter pick on behalf of the Community Council.

Councillor Jones suggested that it would be more beneficial if the days were staggered.

RESOLVED;

That the Clerk, along with Councillor R. Hughes, attempt to stagger the days that the litter picks are carried out.

N.B. The Clerk will report that he has spoken to the Area Supervisor for Leeswood, and arrangements have been made for the Flintshire County Council litter pick to be carried out on a Tuesday, for the time being.

DEFUNCT ELECTRIC SUB STATION:

Councillor K. McCallum referred the old sub station, on the village road prior to Stryt Cae Redyn. The wooden gates at its entrance were now dilapidated, Councillor McCallum considered this to be an area where nefarious activities could be carried out.

Councillor R. Hughes agreed to bring the matter to the attention of the Flintshire County Council and to the North Wales Police.

Councillor R. Hughes informed that he would contact the Flintshire County Council, Street Lighting Department, the following day.

Councillor R. Hughes also informed of a defective street lighting column in the vicinity of the Church, again this would be addressed.

DINGLE ROAD – HEDGE CUTTING:

Councillor E. Saul brought this matter to the attention of the meeting.

RESOLVED:

That the matter be reported to the respective authority.

110.

STRYT CAE RHEDYN, LEESWOOD:

In response to the Community Council's request for the 30 m.p.h sign to be moved prior to the acute bend on Stryt Cae Rhedyn, and the question as to why "The Nant" is subject to a 30 m.p.h speed restriction, in the absence of street lighting, the Head of Assets and Transportation advised that speed limits are normally defined by a Traffic Regulation Order, or a system of street lighting.

The fact that the Nant is a 30 m.p.h. area, would appear to be as a result of a Traffic Regulation Order.

With regards to the visibility of the 30 m.p.h. sign in Stryt Cae Rhedyn, the writer advised that the version of chapter 3 was published in 2008, the previous version was produced in 1986, and contained no reference to minimum clear visibility distances, and even the 1986 chapter was probably not published when this speed limit was introduced.

The Vice Chairman, Councillor K. McCallum, made reference to the fact that in his opinion the area is most dangerous, for vehicles coming in to Leeswood, he spoke of an incident where a large vehicle came around the sharp bend in the middle of the road.

Councillor McCallum continued that the writer be asked to consider the possibility of placing a sign "oncoming traffic in the middle of the road".

Councillor E. Saul advised that this would not comply with modern regulations, as it would be necessary to have two such signs.

The Vice Chairman, Councillor K. McCallum, suggested therefore that such a sign could be erected either side of the bad bend.

RESOLVED:

1. That Councillor E. Saul draft a response on technical grounds to the point made by the Head of Assets and Transportation, with regard to road traffic regulations.
2. That the officer be asked to consider the possibility of erecting a sign "oncoming traffic in middle of the road", either side of the S bend.

APOLOGIES FOR ABSENCE

115. POLICE LIAISON

PC Gary Aldous, Community Beat Manager for Leeswood, along with PCSO Miss Lisa Hughes were present, following acceptance of an invitation to address the Community Council.

Cllr Carlton Jones opened the discussions by referring to the fact that there are a number of issues that need to be stamped out within the village, he mentioned three houses, where in his opinion there were drug problems, he further referred to a recent altercation, again stemming from, in his opinion drug related issues.

Cllr Jones continued by referring to a comment made by a parent governor at Ysgol Derwenfa whereby he expressed a concern of people in the village, and as a result of drug issues, both himself and others were considering leaving the area.

PC Gary Aldous wished to outline his position inasmuch that he has responsibility for twenty two villages across eight wards, and that he is backed up by Police and Community Support Officers, to whom he has given instructions to be on foot as much as possible in order to gain the confidence of the residents.

He continued that he has a particular interest in drug abuse, and that in Leeswood recently, there has been three warrants served.

He encouraged members to report to him as soon as possible any matters of concern, and not to wait for a meeting, he was shocked to hear people were considering leaving the village.

He considered that criminals see Leeswood as a safe haven; who will come to Leeswood from other areas, such as Mold.

Cllr R Hughes made the point that if the Police are making it hot in Mold for them to move to Leeswood; then please make it hot in Leeswood.

Cllr C E Jones also mentioned that double parking is causing concern.

PC Aldous agreed to attempt to address these issues without enforcement action.

Cllr R Hughes informed of the occupant of a small red car, attempting to entice children, this had happened over the last six weeks, PC Aldous was not aware of this.

Cllr R Hughes now referred to the problem of speeding, within the village, he informed that there is a speed activated sign, but now motorists are more or less ignoring it; he questioned the possibility of using the speed gun, which had been previously promised.

PC Aldous responded that there are now less Officers available, and that a lot of the functions that used to be performed, have now been taken away, however he would do his utmost to bring this about.

Cllr Mrs C Bie stressed her concern with regard to the increase in crime in Pontblyddyn, she read out a long list of crimes that have taken place in the village over recent months.

PC Aldous informed that these crimes are linked to a group of people from the Wrexham area, and an operation is currently ongoing to detect these, and in fact arrests have already been made..

Cllr Mrs Bie considered that there was a common thread and that people feel unsafe in their homes, she asked PC Aldous if possible, if he could carry out some home visits.

The Vice Chairman, Cllr K McCallum referred that PC Aldous has twenty two villages; he questioned what the responsibilities of Lisa are. He was informed that Lisa has the villages of Leeswood, Pontybodkin, Pontblyddyn, Tryddyn and Nercwys too.

Cllr K McCallum referred to what used to be regular visits from the Police Officers which were found to be very useful, he referred to a recent letter from the Inspector which informed that Police attendance now would only be in response to a letter.

PC Aldous responded insomuch that he would love to attend every single Council meeting, and that he has attended meetings on his rest day, and that he would expect his PCSO's to attend Council meetings.

Cllr Mrs C Bie asked PC Aldous what is the rota of Lisa, he advised that it is somewhat complicated; PCSO's often worked until twelve midnight but now they are only allowed to work alone until 10 pm, and till midnight only if there are two Officers working together.

Again dependant upon incidents in other areas, PCSO's are often called away to assist in other location. PC Aldous reassured in his belief that the link between the Police and people is very important.

Cllr Dr G Sherwood asked if Arrive Alive could visit Leeswood, PC Aldous informed that this could not be the case, as Arrive Alive operates only trunk roads.

Cllr G Sherwood questioned what the current Policing organisation is.

PC Aldous informed that Mold Police Station was the hub for South Flintshire, from where Officers and motorised Policing would depart from Mold to the various outlining areas.

However the situation now has reverted back to Area Police Stations.

Cllr C E Jones questioned how many Police Stations were open.

PC Aldous informed that Buckley Police Station is open, but with no Police present, Mold is open but there is no custody suite, Flint Holywell and Deeside are open but not for long.

Cllr R Hughes posed the question therefore that if a person is arrested in Leeswood, then where he or she goes to, the answer being Wrexham or St Asaph.

The Chairman, Cllr Miss M Reynolds questioned the area that PC Aldous has responsibilities for; she was informed Cefn-y-Bedd to Cilcain.

In response to Cllr Carlton Jones question with regard to Senior Officers, he was informed that South Flintshire has a Sergeant, and a District Inspector, and that there is Traffic cover from Prestatyn to the Cheshire boarder.

Cllr Carlton Jones commented that we hope that we have given you some valued information.

The Chairman, Cllr Miss Marie Reynolds thanked PC Aldous, and PCSO Lisa Hughes for attending the meeting and for what had been a valuable dialogue.

116. BETSI CADWALADR UNIVERSITY HEALTH BOARD PROPOSALS

Cllr R Hughes referred to the proposal to close the Minor Injuries Unit at the Mold Community Hospital, and suggested that as this provides an excellent service to the Leeswood area, then that the proposals should be objected to.

He referred to the excellence of the X-ray unit, as well as the Minor Injuries Unit.

Cllr Dr Graham Sherwood supported the sentiments of Cllr Raymond Hughes, he again referred to the excellent service provided by the Minor Injuries Unit, and invariably a person is seen within fifteen to twenty minutes.

Resolved

That the Clerk prepares an appropriate objection to the Health Board's proposal to close the Minor Injuries Unit, at Mold Community Hospital.
